Product regulatory status

According to the **UK Food Supplements Regulations** and the **EU Food Supplements Directive 2002/46/EC**, a food supplement is defined as a concentrated source of a vitamin, mineral, or other substances with a nutritional or physiological effect. These supplements are intended to supplement the normal diet and are sold in dose form. Vaion's NAD+ fits within this definition as it is marketed for its physiological benefits related to energy and longevity without making medical claims.

Key Points Supporting Supplement Classification:

1. No Medicinal Claims:

- Vaion's product does not claim to treat, prevent, or cure any disease, which is a critical factor in determining its classification. According to the MHRA, a product is classified as a medicinal product if it is presented as having properties for treating or preventing disease or if it modifies physiological functions to a significant extent.
- The language used to describe Vaion's product as an "energy booster" and a "longevity product" aligns with acceptable claims for food supplements. These claims are focused on maintaining or supporting health rather than treating specific conditions, which falls under the scope of food law, not medicine.

2. Administration Context:

- While the product is administered via IV, which is less common for food supplements, the key determinant is the intent and presentation of the product. Since the product is not promoted with therapeutic claims, the administration method alone does not necessitate its classification as a medicine.
- The controlled administration by physicians in IV clinics ensures the product's safety but does not change its status as a food supplement, particularly if the product's use is consistent with the guidelines for supplements and not for therapeutic treatment.

3. Ingredients and Safety:

• NAD+ is a naturally occurring molecule that plays a crucial role in cellular energy production. As long as the product is manufactured following food supplement regulations (including purity, dosage, and safety standards), it can be legally marketed as a food supplement.

4. Legislative References:

 Vaion product's classification aligns with the Food Information to Consumers Regulation (FIC) (Regulation (EC) 1169/2011) and the Nutrition and Health Claims Regulation (Regulation (EC) 1924/2006), which govern the claims that can be made for food supplements. Since Vaion product's claims are related to general health maintenance, they do not cross into medicinal territory, thus not requiring a marketing authorization under medicinal product regulations.

Conclusion: Given the absence of medicinal claims, the adherence to food supplement regulations, and the intended use of your NAD+ IV vials as an energy and longevity supplement, it is justified to classify Vaion product as a food supplement rather than a medicinal product. This classification is consistent with both UK and EU regulations for food supplements.




Appendix 1. Claim comparison.

Below are key points to justify that Vaion product is a food supplement that falls under the UK Food Safety Act and Food Supplements Regulations 2003:

Appendix 2. FAQ

1. Is the Product Safe?

Yes, the product is safe when used as directed. NAD+ is a naturally occurring molecule in the human body, playing a crucial role in cellular energy production. Vaion Health ensures that the product is manufactured in compliance with food supplement regulations, which include rigorous standards for purity, dosage, and safety. Additionally, stability testing and a Certificate of Analysis (COA) support its safety profile.

Vaion follows robust quality control of all raw materials, storage and final product, as well as full traceability. Following HACCP & ISO22000, both based on GMP requirements, ensures high level of quality of products. Stability testing and a Certificate of Analysis (COA) would further support its safety profile. Vaion's product is only shipped with passed sterility & endotoxin test results, prepared from raw materials of at least 99% purity, with accteable levels of contaminants.

2. Is the Product a Pharmaceutical?

No, the product is not a pharmaceutical. According to the UK Food Supplements Regulations and the EU Food Supplements Directive 2002/46/EC, the product is classified as a food supplement. It does not make any medicinal claims such as treating, preventing, or curing diseases. The product is marketed as an energy booster and longevity supplement, which falls under the scope of food law rather than pharmaceutical regulation.

3. Does the Product Require a Doctor's Prescription?

No, the product does not require a doctor's prescription. As a food supplement, the product is available for use without the need for a prescription. However, it is administered by physicians in IV clinics, which ensures safe and controlled use, particularly because it is delivered intravenously.

4. Can a Lay User Buy IV Vials?

No, a lay user cannot buy IV vials directly. The product is designed for administration by healthcare professionals in a clinical setting. 5. Is the Product manufactured according to GMP (Good Manufacturing Practice) ?

However, the product is not a pharmaceutical and it does not require certified GMP manufacturing site, it requires following GMP rules.
